T1.1 : TENDER NOTICE AND INVITATION TO TENDER

The Richtersveld Local Municipality hereby invites tenders for the Port Nolloth Bulk Water Supply – Construction of water main

The works comprise the following:

- The construction of a 160mm ø uPVC spigot pipe,
- The construction of valves,
- Construction of 40 000 litres water storage facility,
- Construction of booster system and pressure regulator

It is estimated that tenderers should have a CIDB contractor grading designation of Grade 4C and higher. Only those tenderers who are registered with the CIDB, in a contractor grading designation equal to or higher than the latest CIDB promulgated contractor grading designation, determined in accordance with the sum tendered will be eligible to tender.

An **80/20** point system is applicable to this bid. A B-BBEE status level verification must be submitted in order to qualify for preference points.
