Formal Quotation should not be faxed or emailed as only the original copies will be considered

Bid documents containing conditions of Formal Quotation will be available from 07 October 2021 at Richtersveld Local Municipality, Finance Department, 169 Main Road, Port Nolloth.

Formal Quotations will be evaluated in terms 80/20 Preference Point System prescribed by the Preferential Procurement Policy Framework Act of 2000, Preferential Procurement Regulation 2017 and the Municipality's Supply Chain Management Policy.

Following Conditions will apply to the Formal Quotation

- The Richtersveld Municipality Supply Chain Management Policy will apply
- The Richtersveld Municipality does not bind itself to accept the lowest bid or any other bid and reserves the right to accept the whole or part of the bid or to withdraw,
- Bids which are late , incomplete , unsigned , completed in pencil, submitted by facsimile or electronically , will not be accepted
- Bids submitted are to hold good for a period of 365 days
- Bids must only be submitted on the documentation provided by Richtersveld Municipality , (original Bid documents)
- Bidders must be registered on the National Central Supplier Database (CSD) official website – www.csd.gov.za
- **CSD Report reflecting Tax Compliant Status – must accompany the bid document**
- **Certified copy** of the latest Municipal Account on the address of the business must be submitted with the bid document
- **NB:Bidders may not be in arrears for more than three months with Municipal rates and service charges**
- **Certified Copies** of identity document (ID's) of all shareholders/owners(s) partners of bidding companies must be submitted with the document
- **Certified Copies** of Company Registration documents (CK 1) must be submitted with the bid document Service providers /contactors- must submit a certified **copy** of their BBBEE certificates from an accredited BEE Verification agency with their Formal Quotation submission an original or Sworn Affidavit. Failure to submit a BBBEE certificate or original Sworn Affidavit will lead to forfeiture (loss) of the preference points. Bidder/s will not be disqualified from the bidding process if the bidder does not submit a certificate substantiating the BBBEE status level of contribution or is a non – compliant contributor. Such a bidder will score 0
- **Failure to comply with these condition will result in immediate disqualification of your bid.**
- Prospective bidder must submit prior knowledge and experience of Supply and Delivery of goods and Provide references thereof.
- No Formal Quotation will be considered from a person or company who, for the past Five years has been convicted of

- Bidders must include sample tender

- Cost of delivery and packaging must include in price.
- Offer should be per 100 bags including VAT.
